**Format:** All events - best of **3** games to **15** points except women singles – best **3** games to **11** points. Format will be Open with a drop flight bracket for a minimum of 2 matches per event (Entries permitting we will adjust the brackets for an additional drop flight for a 3<sup>rd</sup> match).

**Fees:** USD\$25 first event, USD\$10 for each additional event. Canadian players may make payment at the door but registrations must still be submitted by due date below and only US cash will be accepted at the door. **\$10 surcharge if payment is made at the door for all others.**

**Fees cover:** Awards and shuttlecocks. Concessions will be sold by Sports USA. **SPECIAL NOTE: Outside food and drinks are strictly prohibited from being brought into the facility and ONLY water will be allowed on the courts. No sports drinks are permitted on the courts OR bleachers.**

**Deadline:** Must be postmarked by 09/14/03 or received by Eric Lee no later than Wednesday 09/21/03.
